Timeline for Ridgeview Elementary School: Planning to Transition to Ridgeview Elementary School:

- I. Ribbon Cutting: Early June– August 2023: Potential dates under consideration and to be determined.

  - Determining # of Classrooms Available and Needed: Oct/Nov. 2022
     We have determined that 33 classrooms will be utilized in PK 5<sup>th</sup> grades with a pupil-teacher ratio of approximately 1:17 in grades PK- 3<sup>rd</sup> grades, and 1:17 pupil-teacher ratio in grades 4<sup>th</sup> and 5<sup>th</sup> grades. Grade-level classrooms, self-contained classrooms, and classrooms for Resource programs such as Title I, Encore programs, Attendance, and SROs have been identified.
    - a. Identifying Administrative Staff: Dec./January 2023: The deadline for letters of interest for administrative positions at RES was Friday, Nov. 18, 2022. The School Board will consider these Letters of Interest and potential administrative positions in December 2022.
    - b. Identifying Staff: PK 5<sup>th</sup> Feb/March 2023: The process to determine RES faculty and staff has begun and is under consideration.
    - c. Finalizing Educational/Instructional Programs: April- June 2023: Instructional Staff
    - d. Finalizing Transportation/Bus Runs April/May 2023: Mr. Mooney
    - e. Teacher/Moving Plan: May/June 2023: This topic is on the weekly Skanska Construction calls: The discussion centers on hiring moving companies to help with the move.
