

h. Update on New Elementary School Construction Project

Tim Burge, the Construction Superintendent for Skanska, presented a new elementary school project report and updated the School Board on the construction project.

Mrs. Robinson gave an update on the PPEA/New Elementary Wing with Members of the Board of Supervisors and School Board

On Wednesday, Sept. 29, 2021, the Chairs, Vice-Chairs, of the School Board, and Board of Supervisors met to discuss the PPEA process for the new wing of the Elementary School. Mrs. Robinson asked Scott Mullins to update the Board on that meeting and what the Board of Supervisors completed or accomplished with the resolution.

Scott Mullins: I'm very pleased to report that last night the Board of Supervisors approved of us moving forward with the new edition and they passed a resolution that I'd worked with their attorney on collaboratively with Skanska that would do the things that are necessary to be done under the PPEA procurement. That passed unanimously and I felt very good about that. It's good to be untied in these projects. We've always been told by the school board that there was a desire to build the biggest most adaptable schools that we could within our budget balanced against of course we want to use quality materials for what we build has to be able to stand the test of time. You could always build bigger if you use lesser materials but to build a school that will stand the test of time would be adaptable to future needs. With that background, when we started out we were used exclusively Corps of Engineers money to build this new school and that's going very well. We saw another pot of money become available that was not Corps of Engineers money

and that was what's been referred to as the ESSER money and in July we started a fairly involved process of applying for that money and then we were delighted that in August it was approved and we ended up with an additional \$5.1 million to put into construction. As soon as that was approved on September 1, 2021, we received a PPEA proposal from the people that are building the elementary school now to build a new wing. The new wing would be designed in a way that would seamlessly fit into the new school that's being built. The way it works under the PPEA and under the procurement laws is that they made a proposal and if you notice in your local paper we've been advertising to the world and we put it on websites for contractors to look at and if other people want to bid on this they can. That process ends on October 30, 2021, and when that's over we see what bids we have we will work with Skanska to evaluate those bids and will keep you in the public updated but our goal is to seamlessly transfer over into building that new wing even though won't be completed in the same year it will be the following school year before it's completed. Basically, we want to create something that can adapt for future years and it will be an ongoing process right now it's going very well.

i. Discussion of Guidelines for Unscheduled Remote Virtual Learning Days

Mr. Mark Mullins presented the proposed plan for Unscheduled Remote Learning Days and the proposed Inclement Weather Related Closures.

Definition of an Unscheduled Remote Learning Day:

An instructional day that was originally scheduled to be in-person but, due to inclement weather or other emergency situations, a conversion into a remote learning day becomes necessary. Other emergency situations refer to those circumstances presenting a threat to the health or safety of students including, but not limited to, natural and man-made disasters, energy shortages, or power failures.

Considerations:

When considering declaring an unscheduled remote learning day due to severe weather conditions or other emergency situations, school divisions must have a plan to ensure:

- Power and other required utilities necessary for the provision of instruction and services are still available for students and staff throughout the division;
- Students receiving supports under an Individualized Education Program (IEP) or 504 Plan will be able to access services, as applicable and appropriate;
- The division will provide student support services (e.g. counseling, consultation, assessment, skill instruction) to students, as appropriate;
- The division maintains school meal services for students.

- Divisions will need to consider their current service delivery model used for remote learners. When severe weather conditions or other emergency situations are anticipated, divisions should activate local plans to provide meals in advance of or during severe weather conditions or other emergency situations.
- All teachers and staff have been provided expectations for the provision of instruction and services to all students;
- Student services personnel have been provided expectations for the provision of services to all students;
- All students have computing devices, Internet connection, and/or other supplemental supplies necessary for successful engagement in instruction; and
- Any student that may be unable to access remote instruction and/or assignments will be provided sufficient opportunity to complete instruction and/or assignments without penalty.

- Virtual Instructional Schedule should follow the closely instructional in-school schedule
- Instructional Schedule from 10:00 3:00 p.m. will be posted on Google Classrooms and shared with students and parents by Nov. 12, 2021
- Virtual Day Lunch for students and staff will be scheduled from 12:00 12:45
- For students unable to access remote instruction and/or assignments will be provided packets to complete for the Virtual Learning Day OR provided sufficient opportunity to complete instruction and assignments.

j. Update on ViSSTA

Mrs. Denechia Edwards, CTE/Special Education Director, updated the School Board regarding DCPS's participation in the ViSSTA program which began in early October.

The Virginia Department of Health (VDH) and Virginia Department of Education (VDOE) are partnering to develop the Virginia School Screening Testing for Assurance (ViSSTA) program, which will offer COVID-19 testing to K-12 schools across the Commonwealth for the 2021 -2022 school year.

The ViSSTA program supports screening testing. Screening testing is the regular testing of asymptomatic individuals to identify asymptomatic and presymptomatic cases of COVID-19 with the aim of catching cases early and stopping further transmission. Through the program, VDH/VDOE will match school divisions/schools with testing vendors that will conduct on-site testing. VDH/VDOE will also provide schools with staff and resources to support program implementation and assist in COVID-19 mitigation as schools return to full in-person instruction.

COVID-19 testing is intended for school students, staff, and teachers and will be voluntary; only individuals who consent will be tested at no cost. DCPS is also participating in diagnostic tests for our students and staff to identify early positive COVID tests.

VI. BOARD COMMENT

Jamie Hackney: I am glad to be back this month and glad to see everyone healthy.

Damon Rasnick: I'd just like to thank everybody for working so hard. It's been a tough couple of years and I know everybody's working hard to catch them up I suspect this year the SOLs will probably count. Will they not? Mrs. Robinson: Yes sir. We need to be as productive as we can to help those children reach the same level that they need to be recognized and move on in the school division as well. It is a difficult task we face but I believe sincerely that if everyone pulls together as a team we can be successful. I value each employee that we had every family we represent. In this county were all much alike were ever or whatever district we live in I think we all share the love for children and we want to see what's best for our children. Sometimes it's kind of hard to decide, some people think school boards can decide what they choose but that's not true. We work under a layer of laws from the federal government to the state government and the state organizations. When you work in public schools you have the public health department in matters of dealing with public health they have much more to say about it than school boards do. Sometimes that creates a conflict among the community and among families and among school boards and the people they represent. It is difficult to explain because it seems so simple to do. I think what Mrs. Edwards explained there should be a welcome sigh of relief to everyone and every family. This thing is not gone and it's not going away for some time apparently. We have to deal with it and keep our folks as safe and as we possibly can. I think we've done a good job and will continue to go to a good job but it takes everybody pulling the same way to make this as successful as it can be. I do appreciate everyone's efforts in trying to make our children be the best they can be.

Jason Hicks: I'll just say every other school division is going through this but it seems like it's kind of extra us. Staffing whether that be from classroom teachers to bus drivers and everything else. There's not a whole lot of people going back into education as a whole. I've heard that there are school districts out there that are offering \$7000 sign-on bonuses to students coming out and coming in and signing up. These are divisions that are close to us and it's getting harder and harder for us to compete. That puts extra our staff altogether and students suffer from that. We're going to go through some growing pains with this I think in the next little bit and I hope that there's some solution to that we can find somewhere along the line. As I said earlier the Monday off deal I think we deserve it. Whoever has some unfortunate circumstances from that I'll apologize for that now because it will turn out that way from the unintended. everybody's doing a good job. It's impressive with the testing part. It's really great to start seeing these numbers come down and I hope we can continue to see that continuing trend.

Rick Mullins: I keep going back to the attendance percentages even with COVID how great our attendant percentages have been. The teachers and principals and administration staff have done a phenomenal job in getting to do that and I want to thank each of you from the bottom of my heart for that.
