

g. Update on New Elementary School Construction Project

Tim Burge, the Construction Superintendent for Skanska, presented a new elementary school project report and updated the School Board on the construction project.



h. Discussion of the Emergency Paid Leave Request

At the August 2021 School Board Meeting, the School Board requested that the administration review the Emergency Paid Sick Leave and its potential implementation for the 2021 – 2022 school year.

Our analysis indicated:

- •The total wages paid in Emergency Paid Sick Leave (EPSL) from April 1, 2020, to April 30, 2021, was \$64,457.66
- •The associated FICA was \$4,931.01
- •The Total Cost of COVID Leave was \$69,388.67 for 11 months.
- •The eligible amount for reimbursement through ESSER I or II is \$66,222.32
- •The amount paid by DCPS through State/Local Funds per not eligible by FFCRA guidelines is \$ 3,166.35.

The amount budgeted in ESSER I for EPSL was \$ 45.000 which exceeds the total cost of COVID Leave.

The amount that can be revised into the ESSER II Budget to be reimbursed: \$21,222.32 for the 20- 21 school year:

If the School Board approved Emergency Paid Sick Leave (EPSL): Based on the averages from the prior school year, an **additional \$6,500 per month** for August through December or **\$32,500.00** would need to be diverted from other budgeted uses.

Recommendations for the School Board's Consideration in Implementing EPSL:

- •The Emergency Paid Sick Leave Request for COVID-19 related absences would be effective from Aug. 1, 2021, through Dec. 17, 2021.
- Employees are eligible to receive a maximum of 10 days' EPSL during this time period.
- •Staff members who test positive for COVID-19 (with documentation) would be eligible for 10 days of EPSL.
- •Staff members who had to quarantine would be eligible for 5 days of EPSL. Adults can test after the 5th day, and if negative, can return to work on Day 7 or 8. If a staff member tests positive after the 5th day, they are eligible for 5 additional days of EPSL.
- •The Emergency Paid Sick Leave would not extend after Dec. 17, 2021.
- •An EPSL Form would be completed by eligible staff members' paid leave requests.

Following a motion by Dr. Lurton Lyle and second, by Jason Hicks, the Emergency Paid Sick Leave for employees was approved through December 17, 2021. *Vote results*

i. Approval of VSBA Policies: DCPS Policy: EFB: Food Services and GAA: Staff

Schedules

Karen Martin, Compliance Director, presented the proposed revised policies: DCPS Policy EFB: Food Services and GAA: Staff Schedules:

In summary, the proposed changes are:

EFB- Food Services

Added a paragraph under the subtitle <u>of Unpaid Meal Charges</u> to reflect the Community Eligibility Program and all students receiving free breakfast and lunch. It also addresses assurance of no federal child nutrition funds are used to offset the cost of unpaid meals.

GAA: Staff Time Schedules

Minor vocabulary changes and editing. Statements added to reflect that non-exempt employee may receive compensatory time off at a rate of not less than one and one-half hours. Employees may use compensatory time within a reasonable period. Employees may accrue a maximum of 240 compensatory time hours before they will be provided overtime pay at the rate earned by the employee.

j. Approval of the DCPS Child Nutrition Program Procurement Plan

Laura Taylor presented a proposed DCPS Child Nutrition Programs Procurement Plan 2021. A Procurement Review was completed by Child Nutrition Program (CNR) Procurement Review Team in April 2021. CNR recommended that DCPS update the Procurement Plan as it was last updated in 2018 and some changes in Approved Vendors had occurred. This was not a finding, only a recommendation. This revision of the procurement plan resulted from recommendations from the CNR Procurement Review Team.

The Procurement Plan is meant to be a living document that updates as needed when changes occur. This version was revised by Deborah Compton, Food Service Coordinator, and reflects current information as related to Nutrition Program Procurement at Dickenson County Public Schools.

k.Discussion of Quarantine Days for Students

Mrs. Robinson: While we have followed the CDC's and Health Department's preferred recommendations, the school division's participation in ViSSTA does allow the school division to consider other options and flexibility.

Option1: DCPS remains with the 14-day recommended and preferred quarantine period for students.

Option 2: With the implementation of ViSSTA and free testing opportunities in our schools, the School Board recognizes the undue physical, mental and economic hardship for students and families with the 14-Day quarantine, and transitions to the 10-Day Quarantine. With the Vissta program, students can test on Day 10, and return to school on Day 11 or Day 12 if the results are negative. This additional testing on Day 10 provides another layer of protection for students and staff.

Option 3: Students can return to school on day 11 if they exhibit no symptoms. Testing on day 10 is strongly recommended but would not be required.

VI. BOARD COMMENT

Rick Mullins: It's really good to hear that the rates are down throughout Virginia and hopefully that's to come here and to be able to get back to a case of normalcy. It's really good to see Tim Burge here with all the growth of the building of the school and I just really feel good about that as time goes by.

Dr. Lurton Lyle: I want to apologize again for my late arrival. That was my story and I'm sticking to it.

Jason Hicks: I appreciate everything that the teachers and bus drivers and all the staff are doing at this point in time and I know that it's a difficult process at the moment dealing with still what is leftover from the pandemic. I feel like it's going to be a good thing to offer this emergency leave for our teachers. Looking at it they have said that the peak of the trend in Virginia and hopefully here as well is supposed to be late September early October lets hope that that pans out. Looking at the positivity rates, they seem to be slowly coming down even though there are high numbers so hopefully were headed in the right direction. Hopefully, this going through December will take care of our folks at this point in time. It's really good. I do think that making a move on these quarantine numbers in being able to cut that down for our students and families by a few days will help that out as well. I hope that we're revisiting this pretty soon that maybe we can do without testing those symptoms because it's moving away. That's my hope but we've all been hoping for something like this for a long time. Now let's just hope that it continues but I still just appreciate everything everybody does I know it's a tough job.

Damon Rasnick: I'd like for everybody to know that we all want our children in school as much as they can be there. Everyone up here, all of us, we want our students to be in school we want them to be healthy. We want them to be protected. We don't write rules here on these things, I know a lot of people probably think that we do. We have National Public Health Officials, we have State Public Health Officials and local. For my entire career, I worked with these people and I've never seen them tell us anything wrong. They always gave us information and help in dealing with issues of public health. They are our friends. We certainly are happy to see this 10 days instead of the 14 days I hope that continues. I wish the emergency pay could've been extended to the whole year and taken the strain off. I know that families and employees are strained. The stress is obvious to everyone. For those of us who are parents and grandparents, I know that strain as well. I know that this board will follow the rules as best we can. We will do what the professionals recommend. Actually, by law, we are required to do those things. A lot of people out here ignore those rules. They sometimes encourage us to ignore them but we will not, we cannot. We do what's best for children. We do what needs to be done to protect our children and our families and our employees as best we can. I'd like to give a big thank you to all the employees of the schools and to the parents and grandparents and for all the people involved. Every person up here knows the stress that you're under and we all pray that it leaves us as soon as possible. I want this demon gone forever. And I hope that our county would get up to, I think it's about 50% now that are vaccinated. I wish would go to 90% in a hurry. You know when you have five out of ten not vaccinated it leaves the broad door open for this pandemic to stay with us. The numbers are trending down but they could sure be better. Thank you
